Subject: Request that the Governor Take Action to Protect Maryland's Veterans and the U.S. Department of Veterans Affairs

Dear Governor Moore,

On behalf of the 22 member organizations of the Maryland Military Coalition (MMC), I write on a matter of extreme urgency to the veteran and military community – active duty, Maryland National Guard, Federal Reserves, veterans, their family members, and survivors – in our state concerning draconian terminations that the current administration is Washington is attempting to impose on the U.S. Department of Veterans Affairs (VA). While these terminations have been rescinded by U.S. District Court rulings in California and Maryland, that is only a temporary "fix." As stated in the Maryland ruling<sup>1</sup>, "Nothing in this Order prohibits the Government from conducting lawful terminations of federal probationary employees—whether pursuant to a proper RIF or else for cause, on the basis of good-faith, individualized determinations, under the standards for making such determinations set forth in the foregoing Memorandum, and not as part of a mass termination."

If these court orders are not sustained, the VA has been directed to reduce its workforce by some 80,000 positions, many held by veterans. This arbitrary, unfair reduction-in-force (RIF) was directed without explanation, analysis, or rationale other than cost-cutting. VA operations across its three domains — health care, benefits, and the national cemetery system in Maryland and across the nation will be crippled by these cuts. In our view, the disruption of services will have severe, long-term consequences on the promises made by a grateful nation to tens of thousands of Maryland veterans who raised their hand to 'protect and defend the Constitution of the United States against all enemies foreign and domestic."

As you know, Maryland has a robust VA-funded healthcare system including two hospitals, multiple Community-Based Outpatient Clinics (CBOCs), Veterans Homes, and benefits offices.

The Maryland Military Coalition urgently calls upon you to take concerted action with your fellow Governors of both parties and the National Governors' Association to demand justification under Federal law and regulations for any RIF at the VA that will affect the delivery of health care and benefits to our veterans.

The MMC represents approximately 150,000 of Maryland's 350,000 veterans, not including their families and survivors. Founded on Veterans Day in 2018, the MMC is the leading advocate in Maryland working to protect and defend benefits dearly earned in service to the nation by the Uniformed Services community.
